

## **Higher Education Emergency Relief Fund Report– Emergency Financial Aid Grants to Students**

**Grace Mission University (OPEID: 041578-00)** received education stabilization funds under Section 18004(a)(1) of the Coronavirus Aid, Relief, and Economic Security Act (“CARES Act”), Public Law No: 116-136. This Fund Report applies to the student portion received under the Higher Education Emergency Relief Fund that is designated exclusively for emergency financial aid grants to students.

We take receipt of these federal funds seriously and are distributing them in accordance with the CARES Act and implementing guidance.

As of August 30, 2020, GMU distributed \$25,500 of HEERF funding to 51 Students.

## **Attachment A**

**Method Used:** Financial aid staff confirmed all active students at Grace Mission University met the following Criteria:

- Student have been enrolled in classes in the spring semester on February 2, 2020
- Student must not be enrolled in a completely online program as of Mach 13, 2020
- Student is receiving Title IV funds with Grace Mission University and has a valid 2019/2020 Institutional Student Information Record with no unresolved c-code for citizenship, selective services, default or overpayment.

### **Eligibility Amounts and distribution of the funds:**

We will equally distribute the funding to each financial aid. Every eligible student will receive \$500.00. There is no application required since all financial aid applicants are qualified to receive the fund.

### **Emergency Financial Aid Grants to Students Under the Coronavirus AID, Relief, and Economic Security (CARES) Act**

The U.S. Department of Education has made Emergency Financial Aid Grants to students of our institution who need financial support for their expenses related to the disruption of campus operations due to Coronavirus.
